WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Five Hundred and No/100- - - - - DOLLARS (\$ 5500.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of King Street, near the City of Greenville, being shown as lot No. 9, on Plat of Ethel Y. Perry Estate, recorded in Plat Book S at Page 49, and described as follows:

"BEGINNING at a stake on the Western side of King Street, at corner of lot 8, and running thence with line of said lot, S. 65-46 W. 182.5 feet to a stake in line of lot 6; thence with the line of said lot, S. 9-29 E. 50 feet to a stake at corner of lot 12; thence with the lines of lots 12 and 10, N. 70-39 E. 203.2 feet to a stake on King Street; thence with the Western side of King Street, N. 31-27 W. 65 feet to the beginning corner."
