(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-Three Hundred and Tollie

DOLLARS (\$3300.00 )

with interest thereon from date at the rate of Six per centum per annum, said principal xambinates to be repaid: \$75.00 on 15th day of March, 1952 and a like payment of (75.00 on the 15th day of each month thereafter until maid in full, wit interest thereon from late at the rate of Six (6%) per cent, per annum, to be computed and paid annually in advance.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oakhawn Townshir, on the Western side of U. S. Highway No. 29, being shown as lots Nos. 44, 45, 46, 47, 40, 40, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59 and 60 on a plat of the property of T. D. Bennett, made by G. Sam Lowe, on August 24, 1948, and recorded in Plat Took S. at Page 143, and described as follows:

"BIGI.NING at a stake at the Northwestern corner of U. S.
