C. Langford, his heirs and assigns forever:

All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about three miles east from Travelers Rest, S. C. on both sides of the McElhany Road and on the south side of the Log Ford Road and on the north side of Beaverdam Creek, the same being shown and designated as Lot No. 2 in the subdivision of the A.J. Gilreath Estate on a plat of the property of that estate made for "A.D. and J. P. Gilreath, et al.", prepared by Will D. Neves, C.E., Surveyor, dated October 20, 1904, and to be recorded in the office of the R.M.C. for Greenville County, and having, according to said plat, the following courses and distances, to-wit:
