"BEGINNING at an iron pin on the northwestern side of Cammer Avenue at the joint front corner of Lots Nos. 17 and 18, which iron pin is 351.95 feet from the intersection of Cammer Avenue and Augusta Road, and running thence along the northwestern side of Cammer Avenue, S. 44-17 W. 76.85 feet to an iron pin, joint corner of Lots 18 and 19; thence leaving Cammer Avenue and running along the common line of Lots 18 and 19, N. 36-24 W. 178 feet to an iron pin in line of Rockwood Park property; thence along the common line of Lot 18 and Rockwood Park property, N. 44-17 E. 76.85 feet to an iron pin, the joint rear corner of Lots 17 and 18; thence along the common line of said last mentioned lots, S. 36-24 E. 178 feet to an iron pin, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
