ALL that certain piece, parcel or strip of land situate, lying and being in the County of Greenville, state of south Carolina, on the North side of the super Highway leading from Greenville to spartanburg and being shown as the Northern most section of an 18 foot street on Plat of Property of S. J. Rimer, prepared by Dalton & Neves, Engineers, December 10, 1946, recorded in Plat Book "Q", at Page 93, R.M.C. Office for Greenville County, South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in line of property formerly belonging to S. J. Rimer, which pin is N.39-00 W. 357.7 feet from the Northern edge of the super Highway leading from Greenville to spartanburg; thence along line of said property, N.31-38 W. 1096 feet to an iron pin in line of property of W. S. Edwards; thence S.57-45 W. 18 feet to an iron pin in line of property of W. T. Edwards; thence along line of W. T. Edwards property, S.31-38 W. 1096 feet to a concrete monument at the Northeastern corner of property of D. B. Black; thence crossing said 18 foot street approximately N.51-47 E. 18 feet to the beginning corner.
