"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the South side of Carey Avenue in the City of Greer, designated as Lot No. 23 and one-half of Lot No. 21 adjoining Lot No. 23, according to survey and plat of the Property of W.C. Smith by H.S. Brockman, Surveyor, dated May 25, 1936, and having the following courses and distances, to wit: Beginning at an iron pin on the South side of Carey Avenue, corner of Lot No. 25, and running thence along Carey Avenue, N. 69.25 W. 85½ feet to stake, new corner; thence approximately S. 22.52 W. along the dividing line of Lot No. 21 about 164 feet to stake; thence S. 69.37 E. 91.3 feet to the corner of Lot No. 25; thence along the line of Lot No. 25, N. 21.48 E. 160.3 feet to the beginning corner.
