with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$50.00 on April 29, 1952, and a like payment of \$50.00 on the 29th day of each month thereafter until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid quarterly in advance.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, being known and designated as lot No. 12 according to plat made by W. A. Hester May 1941, of the property of J. Frank Williams and having according to said plat the following metes and bounds, towit:

"BEGINNING at an iron pin on Old Buncombe Road, at joint corner of lots Nos. 12 and 13, and running thence N. 3-00 W. 30 feet to iron pin, joint corner of lots 11 and 12; thence N. 76-53 E. 89.5 feet to iron pin on G & N Railway right-of-way; thence along said right-of-way, S. 13-30 E. 30 feet to iron pin; thence S. 77-08 W. 95 feet to beginning corner."
