"All the certain piece/parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Wallace Street, near the City of Greenville, being shown as lots Nos. 17 and 18 on plat of F. H. Earle property made by Pickell & Pickell on February 26, 1951, recorded in Plat Book Z at Page 191, and described as follows:
