WHEREAS, I the said William H. Baldwin
in and by my certain promissory note, in writing, of even date with these presents am well a truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in
full and just sum of Seven Thousand, One Hundred and No/100 (\$ 7,100.00 four (4%)) Dollars, with interest at the rate of six/6%/ per centum per annum, to be repaid in instalments
Forty-Three and 03/100
day of each and every calendar month hereafter in advance, until the full principal sum, with interhas been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at a time any portion of the principal or interest due thereunder shall be past due and unpaid for a period thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the hole thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collect by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast side of LeGrand Boulevard in the City of Greenville, being shown as Lot 19 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, recorded in the R. M. C. office for Greenville County, S. C. in Plat Book "BB", pages 30 and 31, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeast side of LeGrand Boulevard at the corner of Lots Nos. 19 and 166, and running thence N. 41-41 E. 174 feet to an iron pin at the rear corner of said lots; thence N. 49-11 W. 72.3 feet to an iron pin at the rear corner of Lot No. 20; thence along the line of Lot No. 20, S. 40-49 W. 161.5 feet to an iron pin at the corner of said lot on the northeast side of LeGrand Boulevard; thence along the northeast side of LeGrand Boulevard, following the curvature there of, S. 39-01 E. 71.6 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
