"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Northern side of Kenwood Drive, being shown and designated as lot No. 8, on plat of Kenwood Place, recorded in Plat Book K at Page 104, and described as follows:
