in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Grace F. Hendrix, her heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being on the North side of Keowee Avenue and being Lot No. 5, according to a plat of the property of e. C. Case, made by W. M. Furman, Jr., Engineer, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book F, page 227, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Keowee Avenue, joint corner Lots Nos. 4 and 5 and running thence with line of Lot No. 4 N. 62-32 W. 172 feet to an iron pin on fifteen foot alley; thence with said alley N. 27-28 E. 50 feet; thence S. 62-32 E. 172 feet to an iron pin on Keowee Avenue; thence with Keowee Avenue S. 27-28 W. 50 feet to the beginning corner.

ALSO, all that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being a strip of the Southern portion of Lot No. 49, as shown on plat of North Cherokee Park, recorded in the R.
