State of South Carolina; near the City of Greenville, Greenville County, South Carolina, all that piece, parcel or let of land with the buildings and improvements thereon, situate, lying and being on the Northern side of Lenore Avenue, being known and designated as Let No. 130, Map No. 3, Sans Souci Heights Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Z, page 95, and having, according to said plat, the following metes and bounds, to wit:
