All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and in School District 8-AA, on the east side of Woodside Avenue (formerly known as Brandon Road), and being known and designated as a portion of Lots Nos. 53 and 54 of a subdivision known as Morgan Hills Addition as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book A, at page 69, and being more particularly described as follows, to-wit:
