"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot No. 29 and the Western one-half of lot No. 30, as shown on plat of Perry Property recorded in Plat Book I at Page 32, and being more particularly described according to said plat as follows:
