All that certain piece, parcel or lot of land situate, lying and
being in the city of Greenville, county of Greenville, state of South
Carolina, on the north side of Mountain View Avenue, being known and
designated as lot No. 2 of the property of J. W. Cannon, as shown on
plat thereof prepared by Dalton & Neves, Engineers, June 1950, re-
corded in plat book T page 289 of the R. M. C. Office for Greenville
County, having according to said plat the following metes and bounds,
to-wit:

Beginning at an iron pin on the north side of Mountain View Avenue,
the joint corner of lots 2 & 3, and running thence with the joint line
of said lots N. 11-46 E. 154.3 feet to an iron pin in line of property
formerly estate of C. C. Hindman; thence with the line of said property
N. 71-37 W. 73.5 feet to an iron pin corner of lot No. 1; thence with
the line of said lot S. 10-41 W. 162.7 feet to an iron pin on the north
side of Mountain View Avenue; thence with the north side of said street
