C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in School District 9-B, on the north side of Conway Drive, and designated as lots Nos. 20 and 21 on plat of the property of A. S. Bass and C. A. Groce, prepared by H. L. Dunahoo, Surveyor, June 23rd, 1947, and together having the following courses and distances, to wit:-
