ALL of those parcels or lots of land in Chick Springs Township of Greenville County, South Carolina, near the City of Ereer and North therefrom, lying on the West side of Ashmore Street, being the Northern one-half of lot No.20 and the greater portions of lots Nos. 21 and 22 as shown on a plat of property made for Mrs. Geanie Caldwell by H.L. Dunahoo, Surveyor, dated October 24-25, 1949, recorded in the R.M.C. Office for Greenville County in Plat Book X, at page 1, and having the following courses and distances;

BEGINNING en a stake on the western margin of Ashmore Street, which stake is equi-distance from the front corners of Lot No.20, and runs thence with the western margin of Ashmore Street N.10.00 W. 172 feet to a stake at intersection of Ashmore Street and Highland Drive; thence along the edge of Highland Drive N.62.30 W. 49 feet to a point, corner of strip of land conveyed by me to Roy E.
