have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, Welcome School District, being known and designated as Lot No. 27 on plat of the property of James H. Campbell, prepared by C. C. Jones, Engineer, June, 1951 and recorded in the R. M. C. office for Greenville County in Plat Book AA, at page 109, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Springfield Avenue at the joint from the intersection of Springfield Avenue with Crescent Street, and running thence along the western side of Springfield Avenue, N. 20-18 W. 80 feet to an iron pin at the corner of Lot 26; thence along the line of that lot, S. 69-42 W. 170.8 feet to an iron pin; thence S. 14-13 E. 80.45 feet to an iron pin at the rear corner of Lot 28; thence along the line of that lot, N. 69-42 E. 179.2 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
