All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southeasterly side of Alleta Avenue, in the City of Greenville, S. C. in Plat Book F, page 154, said lot fronting 75 feet on the Southeasterly side of Alleta Avenue and having a depth of 126.7 feet on the Northeasterly side, a depth of 126 feet on the Southwesterly side, and being 75 feet across the rear.
