NOW KNOW ALL MEN, That we, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Clyde Sandlin, his heirs and assigns, all that lot of land in Greenville Township, Greenville County, State of South Carolina, on the southeast side of Helene Street, near the City of Greenville, being a portion of Lot #5, of Block A, on a plat of the Property of J. Ed. Means, made by W. J. Riddle in January 1940, recorded in Plat Book "J" at pages 186 & 187, and more particularly described as follows:

Beginning at a stake on the southestern side of Helene Street, 680.5 feet northeast from Emile Avenue, and running thence S 29-43-E 175 feet to a stake; thence N 60-17 E, 50 feet to a stake at corner of Lot # 6; thence with the line of said lot N 29-43 W, 175 feet to a stake on Helene Street; thence with the southeast side of said street S 60-17 W, 50 feet to the point of beginning.
