NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Sycamore Drive, near the City of Greenville, being known and designated as lot 114 on plat of East Lynne Addition made by Dalton & Neves, Engineers, May 1933, and recorded in the R.M.C. Office for Greenville County in Plat Book H at Page 220, and described as follows:

"BEGINNING at an iron pin on the Southwest side of Sycamore Drive, at joint front corner of lots 114 and 115, and running thence with the line of lot 115, S. 28-35 W. 193.4 feet to an iron pin; thence N. 63-51 W. 50 feet to an iron pin; thence with the line of lot 113, N. 28-35 E. 195.7 feet to an iron pin on the Southwest side of Sycamore Drive; thence with the Southwest side of Sycamore Drive, S. 61-10 E. 50 feet to the beginning corner."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
