"All that certain piece/parcel/or lot/of land, with all improvements thereon, or hereafter construct ed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the East side of McBee Boulevard, near the City of Greenville, being shown as lots 8, 9, 10, and 11 of Bock "C", on plat of Pendleton Street Realty Essociation, recorded in Plat Book & at Pages 122 and 123, and described as follows:
