WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of TWO THOUSAND & No/100 (\$2000.00) DOLLARS (\$ 2000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, located on the Old Anderson road, or State Highway No. 81 about 2½ miles from the corporate limits of the City of Greenville, being shown as tract No. 4 on plat of Dixie Farms, recorded in the R.M.C. office for Greenville County in Plat Book L. at pages 3 and 5, containing 9.34 acres and being described by metes and bounds, as follows:

BEGINNING at an iron pin at the joint corner of tracts Nos. 4 and 3 and running thence with line of tract 3 N.35-25 W. 355 feet to an iron pin; thence N.40-50 W. 712 feet thence S.23 -30 W. 128 ft. to an iron pin, joint corner of tracts 5, 6 and 4; thence S.14 E.145 ft. to an iron pin; thence S.40-52 E. 196 ft. to an iron pin; thence S.5-07 E. 100 ft. to an iron pin; thence S.41-47 W. 46 ft. to an iron pin; thence S.27 W. 100 ft. to an iron pin; thence S.10 E. 165 ft. to an iron pin; thence S.17 W. 65 ft. to iron pin; thence S.49-35 W. 139½ ft. to the center of County road S.35-30 E.356 ft. to point in center of State Highway No. 81; thence N.47 E.356 feet with said Highway to point; thence continuing with said highway N.55-25 E. 294 feet to the point of beginning.

Said premises being the same conveyed to the mortgagor by E.R.Parker by deed dated April 8th.1939, recorded in Vol. 210 at page 8.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
