"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Wilderness Lane, in the City of Greenville, being all of lot No. 109, the Eastern one-half of lot 110 and the western portion of lot 108 on plat of Cleveland Forest, recorded in Plat Book M at Page 137, and described as follows:
