MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Cecil D. Blakely, of Greenville County, SEND GREETING:

WHEREAS, I the said Cecil D. Blakely

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the full and just sum of Four Thousand Two Hundred and No/100 - - - (\$ 4,200.00 )

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of Forty-Two and No/100 - - - - - (\$ 42.00 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I, the said Cecil D. Blakely

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

the said Cecil D. Blakely in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, near the City of Greenville and just off the Laurens Road, on the west side of McAdoo Avenue, and being known and designated as Lot No. 84, of Glenn Grove Park, as shown on plat of said subdivision made by R. E. Dalton, Engr., May, 1924, and recorded in the R. M. C. office for Greenville County in Plat Book "F", at page 233, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the west side of McAdoo Avenue at the joint corner of Lots Nos. 84 and 85, which point is 171.2 feet south from the southwest corner of the intersection of McAdoo Avenue with the Laurens Road, and running thence along the joint line of said Lots 84 and 85, N. 70-56 W. 150.2 feet to an iron pin; thence along the rear line of Lot No. 96, S. 15-48 W. 58.5 feet to an iron pin, joint rear corner of Lots Nos. 84 and 83; thence along the joint line of Lots Nos. 83 and 84, S. 74-12 E. 150 feet to the joint corner of said lots on McAdoo Avenue; thence along the line of McAdoo Avenue, N. 15-48 E. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Mary Grace Fincher by deed dated July 24, 1943 and recorded in the R. M. C. office for Greenville County in Vol. 255, page 209."
