MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Charlie Thomas Jones and Emily E. Jones, of Greenville County SEND GREETING:

WHEREAS, we the said Charlie Thomas Jones and Emily E. Jones

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Four Thousand, One Hundred and No/100 - - - - (\$4,100.00)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

Thirty-Four and No/100 - - - - (\$ 34.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 8, of Section B, of a subdivision known as Woodville Heights according to a plat thereof made by W. J. Riddle, Surveyor, December, 1940, recorded in the R. M. C. office for Greenville County in Plate Book L, at pages 14 and 15, and having, according to said plat, the following meters and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of Cak Street, the joint front corner of Lots Nos. 7 and 8, Section B, and running thence along the southwestern side of Cak Street, N. 45-40 W. 70 feet to an iron pin, corner of Lot St. 5; thence along the line of that lot, S. 44-30 W. 135 feet to an iron pin; thence & 44-32 To feet to an iron pin at the rear corner of Lot No. 7; thence along the line of that lot N. 44-30 E. 136 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to us the Ernest R. Dodson and Essie O. Dodson by deed of even date herewith, that yet excessed."
