"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, in a subdivision known as "City View", about two miles west of Greenville County Court House, being on the west side of Brandon Road (sometimes called Woodside Avenue).

"BEGINNING at an iron pin on southwest corner of Brandon Road, and O'Neal Avenue (now Morgan Street) and running with said Brandon Road in a northerly direction 65 feet and 10 inches to an iron pin; thence parallel with O'Neal Avenue in a westerly direction 146 feet to an iron pin; thence in a southerly direction, parallel to Brandon Road 65 feet and 10 inches to O'Neal Avenue; thence with O'Neal Avenue in an easterly direction 146 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to us by J. L. Aiken, et al. by deed dated March 15, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 430, at page 547 ."
