"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, School District 160, formerly 6-E, being known and designated as Lot No. 41 of a subdivision of the property of Talmer Cordell as shown on preliminar of Cordell Subdivision No. 10 according to plat thereof made by C. C. Jones in August, 1952, and being more particularly described as follows, to-wit:

"BEGINNING at an iron pin on the north side of Bent Bridge Road at the corner of Lot No. 40, and running thence along the north side of Bent Bridge Road, in a southwesterly direction, 70 feet to an iron pin at the corner of Lot No. 42; thence along the line of that lot, in a northwesterly direction, 225 feet, more or less, to an iron pin in line of Lot No. 38; thence along the line of Lot No. 38, in a southeasterly direction, 75 feet, more or less, to an iron pinat the rear corner of Lot No. 40; thence in a southerly direction along the line of Lot No. 40, 200 feet, more or less, to an iron pin on the north side of Bent Bridge Road, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
