before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CTTIZENS BUILDING AND
LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Town-Ship, and having the following metes and bounds and courses and distances:-

EEGINNING at an iron pin on the east side of the right of way of Walnut Lane, in the mub-division known as Lee Roy Park, at the front joint corner of lots No. 20 and No. 21 and running along line of said lot No. 20, N. 86-45 E. 300 feet to an iron pin at the rear joint corner of lots No. 20 and No. 21; thence N. 3-15 W 100 feet to an iron pin at the rear joint corner of lots No. 21 and No. 22; thence along line of lot No. 22 S. 86-45 W. 300 feet to an iron pin at the right of way of Walnut Lane; thence S 3-15 E 100 along right of way of said Walnut Lane, to the beginning corner.

This is better known as lot No. 21 as shown on plat made for Lee Roy Styles, by Pickell and Pickell - Engineers, in September 1950 and recorded in Book Y at page 63, in the Office of R. M. C., Greenville County.
