"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Eastern corner of Frank and Pinckney Streets in the City of Greenville, and eing described as follows:
