"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Towns ip, known and designated as lot 83 of Anderson Street Highlands, on plat recorded in Plat Book "J" at Page 157, and having according to said plat, the following metes and bounds, to-wit:
