COUNTY OF Greenville To All Whom These Presents May Concern:
I, William C. Brooks, of Greenville County, SEND GREETING:
WHEREAS, I the said William C. Brooks
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the
full and just sum of Five Thousand and No/100 (\$5,000.00)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of
Fifty and No/100 (\$ 50.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.
NOW.KNOW ALL MEN. That I, the said William C. Brooks in consideration of the said debt and sum of money aforesaid, and for the better securing the payment
thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-
cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me, the said William C. Brooks
in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed
thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Talley Bridge Road at Slater, and known and designated as Lot 8, Block K, as shown on a plat entitled "Plat Showing Property Owned by Slater Manufacturing Co., Located at Slater, Greenville County, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., December 26, 1951, and recorded in the R.M. office for Greenville County in Plat Book CC, at page 147, and having, according to said plat, the following metes and bounds:
"BEGINNING at an iron pin on the northern side of Talley Bridge Road at the joint front corner of Lots 8 and 9, and running thence along the common line of said two lots, N. 18-09 W. 228.5 feet to an iron pin; thence N. 71-51 E. 140 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence along the common line of

said two lots, S. 18-09 E. 228.5 feet to an iron pin on the Northern side of Talley Bridge Road; thence along the Northern side of Talley Bridge Road, S. 71-51 W. 140 feet to an iron pin, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are here-

by expressly agreed to be a part of the realty. Being the same conveyed to me by J. P. Stevens & Co., Inc. by deed dated September 10th, 1952 and recorded in the

R. M. C. office for Greenville County in Vol. 463, at page 544."
