WHEREAS: I, John L. Catoe

of Greenville, S. C. , hereinafter called the Mortgagor, is indebted to

Fidelity Federal Savings and Loan Association , a corporation organized and existing under the laws of South Carolina , hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixty-five Hundred - - Dollars (\$6500.00), with interest from date at the rate of four per centum (4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings and Loan Association in Greenville, S. C. , or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-nine and thirty-nine one-hundredths Dollars (\$ 39.39), commencing on the first day of December , 19 52, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November , 19 72

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

All that piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, in that section known as Sans Souci about two miles north of the city of Greenville, on the northern side of Paris Mountain Avenue between the Perry Road and Newland Avenue being known and designated as lot No. 56 on plat of said property recorded in the R. M. C. Office for Greenville County in plat book 0 page 45 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northern edge of a 5 foot sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of lots numbered 56 and 57 and running thence along the northern edge of said sidewalk S. 84-28 W. 60 feet to an iron pin, joint front corner of Lots 55 and 56; thence along the eastern line of Lot 55 N. 5-50 W. 150.2 feet to an iron pin, rear corner of said lots 55 and 56; thence along the rear line of lot 33 N. 32-45 E. 60 feet to an iron pin, joint rear corner of lots 56 and 57; thence along the western line of lot 57, S. 5-50 E. 152 feet to an iron pin the beginning corner.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
