"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Potomac Avenue, in the City of Greenville, being a portion of lots 196 and 197 on plat of property of Pleasant Valley, recorded in Plat Book P at Page 114, and being shown as lot No. 1 on plat of property of Asay & Crymes, recorded in Plat Book CG at Page 107 and described as follows:

"BEGINNING at a stake on the Northern side of Ptomac Avenue, 730 feet West from Panama Avenue, at corner of lot 195, and running thence with the line of said lot, N. 0-08 W. 160 feet to a stake; thence S. 89-52 W. 72 feet to a stake at corner of lot 2; thence with the line of said lot, S. 0-08 E. 160 feet to a stake on Potomac Avenue; thence with the Northern side of Potomac Avenue, N. 89-52 E. 72 feet to the beginning corner.
