"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Green-ville Township, on the Western side of Parker Road, formerly Monaghan Road, and having the following metes and bounds, to-wit:

"BEGINNING at a stake at the corner of lot formerly owned by M s. S. D. Olson, and running thence with her line, S. 70-30 W. 154 feet; thence N. $7\frac{1}{4}$ W. 19 feet; thence S. $76\frac{1}{2}$ W. 45 feet to stake; thence N. 46-45 W. 79.5 feet to a stake; thence N. 67-45 E. 145 feet to Parker Road; thence with Parker Road, S. 37 E. 112 feet to the point of beginning.
