"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Eastern side of Donnon Road, in a subdivision known as Super Highway Homes Sites, being known and designated as lot No. 8 on plat recorded in Plat Book P at Page 53, and according to said plat has the following metes and bounds:

"BEGINNING at an iron pin on the Eastern side of Donnon Road, at joint front corner of lots. 7 and 8, and running thence along the joint line of said lots, S. 88-0 E. 182.5 feet to iron pin in center of a 5 foot strip reserved for utilities; thence along the ceter of the 5 foot strip, S. 2-00 W. 80 feet to iron pin, the corner of lot 9; thence with line of lot 9, N. 88-0 W. 182.5 feet to iron pin on Donnon Road; thence with the Eastern side of Donnon Road, N. 2-00 E. 80 feet to the beginning corner."
