"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Northwest side of Chick Springs Road, being shown as lot 28, and all that land known as a private drive directly to the rear of said lot, as shown on a plat of the property of Incy L. Hindman, recorded in Plat Book W at Page 177, and described as follows:

\*BEGINNING at an iron pin on the Northwest side of Chick Springs Road, joint corner of lots 27 and 28, and running thence with line of said lots, N. 72-41 W. 150 feet, more or less, to the middle of Richland Creek; thence with the center of the creek as the line, the traverse of which is N. 46-18 E. 97.5 feet to the joint corner of lots 28 and 29; thence S. 69-33 E. 125 feet, more or less, to an iron pin on Chick Springs Road; thence with the Northwest side of said road, S. 35-25 W. 85 feet to the point of beginning.\*
