M. C. office, and having the following metes and bounds, to wit:

BEGINNING At a stake on the eastern corner of Oak Street and McDowell Street, and running thence with the northeastern side of Oak Street, S. 45-40 E. 161.2 feet to a stake at corner of Lot No. 1 of Section "C"; thence with the line of said Lot No. 1, N. 73-10 E. 49.3 feet to a stake at the corner of Lot No. 24 of Section "C" thence with the line of said Lot No., 24, N. 34-20 W. 166 feet to a stake on McDowell Street; thence along southern side of McDowell Street, S. 60-30 W. 79 feet to the beginning corner.
