"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being a part of lots Nos. 47, 48 and 49 on plat of Lanneau Drive Highlands made by Dalton & Neves, Engineers, August, 1937 recorded in the R. M. C. Office for Greenville County in plat book "D" at page 288 and 289 and having according to a more recent survey made by Piedmont Engineering Service dated July 22, 1950, the following metes and bounds, courses and distances, to-wit:
