"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the East side of the Buncombe Road, near the City of Greenville, being a portion of lots 2 and 3, as shown on plat of property of W. H. League made by W. H. Riddle, July 2, 1937, recorded in Plat Book B at Page 37 and described as follows:

"BEGINNING at a point in the center of Buncombe Road, joint corner of tracts 1 and 2, and at corner of property now or formerly owned by Julia Barrow Robinson, and running thence with line of her property, N. 75-15 E. 729.5 feet to a stake; thence continuing with the line of her property, S. 56-55 E. 844.2 feet to a stake; thence S. 45-30 W. 920.3 feet to a stake; thence N. 26 W. 305 feet to a stake; thence with the line of property conveyed to J. D. Lenderman, S. 59-30 W. 305 feet to a point in center of Buncombe Road; thence with said Buncombe Road 164.5 feet to a point; thence continuing with center of said road, N. 25-40 W. 317 feet to a stake; thence continuing with said road, N. 14-35 W. 394 feet to the beginning corner. Being the remainder of the property conveyed to the mortgagor by deed recorded in Volume 251 at Page 75, after the conveyance of a tract sold to Julia Barrow Robinson by deed recorded in Volume 280 at Page 342, and a tract conveyed to J. D. Lenderman by deed recorded in Volume 325 at Page 195."
