"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the East side of Willis Avenue, near the City of Greenville, being known and designated as lots Nos. 31 and 32, Block B, as shown on plat of property of Alice M. & H. H. Willis made by W. J. Riddle, Surveyor in November 1939, recorded in the R.M.C. Office in Plat Book J at Pages 150 and 151, and when described together have the following metes and bounds, to-wit:
