"All risks certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as lots Nos. 20, 21 and 22 on Plat of the property of Bertie E. Burns, made by R. E. Dalton, Eng., recorded in Plat Book G at Page 30, in the R.M.C. Office for Greenville County, and being more particularly described according to said plat. as follows:
