To ALL WHOM THESE PRESENTS MAY CONCERN: We, T. O. Lunsford and Mary T. Lunsford
of
Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Fidelity Federal Savings and
Loan Association

, a corporation
organized and existing under the laws of South Carolina , hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Eighty-seven Hundred Fifty
Dollars (\$ 8750.00), with interest from date at the rate of four & one-fourth per centum
(4 1/4 %) per annum until paid, said principal and interest being payable at the office of Fidelity
Federal Savings & Loan Association in Greenville, S. C. ,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Fifty-four and twenty-five one-hundredths - Dollars (\$ 54.25),
commencing on the first day of March , 19 53, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of February , 19 73.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina :

All that certain piece, parcel or lot of land in Paris Mountain
Township, Greenville County, state of South Carolina, being known and
designated as lot No. 40 of subdivision known as Leawood, property of
C. M. Gaffney as trustee as shown on plat thereof recorded in plat
book J at pages 18 & 19, and having according to a recent survey made
by R. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeast side of Edgewood Avenue,
the joint corners of lots Nos. 40 & 41; thence with the joint line of
said lots N. 33-54 E. 164.7 feet to an iron pin corner of lot No. 46;
thence with the line of said lot S. 55-41 E. 75 feet to an iron pin
corner of lot No. 39; thence with the line of said lot S. 33-54 W.
165.1 feet to an iron pin on the northeast side of Edgewood Avenue;
thence with the northeast side of said Avenue N. 55-18 W. 75 feet to
the beginning corner.

ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
