Abercrombie's corner, and ru ning thence with the center of side track, S. 44-55 E. 252 feet to a pin in the center of said side track; thence S. 40-13 W. 500 feet to a pin; thence crossing a small branch, N. 44-55 W. 202 feet to a pin on W.
