full and just sum of Three Thousand, Two Hundred, Fifty and No/100 (\$ 3,250.00

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville</u>, near the intersection of Paine Street and Rector Street, being known and designated as Lot No. 8 of the property of Walter W.
