WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, ville Township, on the East side of Tomassee Avenue, near the City of Greenville, known and designated as Lot No. 5 on Plat of property of C. B. Martin, made by R. E. Dalton, Eng., recorded in Plat Book F at Page 102, and being more particularly described as follows:

"BEGINNING at an iron pan on the East side of Tomassee Avenue, 140 feet from the Southeastern corner of Tomassee Avenue and a 20-foot alley, bordering on the property of Augusta Road School District, at corner of Lot No. 3, and running thence with the line of said lot, S. 71-35 E. 177.6 feet to an iron pin, joint corner of Lots Nos. 3, 4, 5 and 6; thence along the rear line of Lot No. 6, S. 16-51 W. 69.9 feet to iron pin; thence N. 71-35 W. 183.4 feet to an iron pin on Tomassee Avenue; thence with the eastern side of Tomassee Avenue, N. 21-35 E. 70 feet to the beginning corner."
