in the Town of Travelers Rest, about nine miles north of Greenville County Courthouse, on the east side of the Buncombe Road, or Main St., being Lots Nos. 9 and 10 as represented on plat made by E. M. Hunt, Surveyor, and dated March and May, 1891 of the lands of R. W. Anderson, deceased, and having the following metes and bounds, to wit:

BEGINNING at a stake on said Main St., or Buncombe Road and running S.  $2\frac{1}{2}$  E. 100 feet to a stake on corner of A.M. Gilreath's lot, formerly owned by L. B. Johnson, now owned by T. J.
