WHEREAS, the Mortgagor is well and truly indebted unto

C. DOUGLAS WILSON & CO.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eight Thousand, Three Hundred Dollars (\$ 8,300.00 ), with interest from date at the rate of Four & One-Fourth per centum ( 4 1/4 % ) per annum until paid, said principal and interest being payable at the office of

C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-Four and 99/100 - - - - - Dollars (\$ 44.99 ), commencing on the first day of April, 19 53, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 19 78.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land with the buildings and improvements thereon, situate on the northwest side of Erskine Street, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 76 on plat of College Heights, made by Dalton & Neves, Engineers, August 1946, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book P, at Page 75, said lot fronting 46.2 feet along the northwest side of Erskine Street and running back to a depth of 150 feet on the northeast side, to a depth of 159.6 feet on the southwest side of said lot along a 20 foot road and being 101.1 feet across the rear.

The above described property is the same conveyed to the mortgagor herein by deed of A. H. McMahan, dated August 4, 1952, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 460, at Page 219.
