ALL those two pieces, parcels or lots of land situate, lying and being in Greenville County, State of South Carolina, on the NW/s of Old Spartanurg Road about 12 miles east of the present corporate limits of the City of Greenville, S.C., being known and designated as lots 7 and 8 on a plat of property of B.F. Trammell prepared by J.C. Hill, Surveyor, on December 8, 1950, and recorded in the RMC Office for Greenville County, S.C., in plat Book ______, and having according to said plat the following metes, bounds, courses and distances, to wit:
