, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eight Thousand, Five Hundred Fifty Dollars (\$ 8,550.00), with interest from date at the rate of Four & One-Fourth per centum (4 1/4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-Six and 34/100 - - - - - Dollars (\$ 46.34), commencing on the first day of May, 1953, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 1978.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land, with the buildings and improvements thereon, situate on the west side of Crosby Circle, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 210 on plat of Paramount Park, made by Piedmont Engineering Services, July 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "W", at Page 57, said lot fronting 100 feet along the west side of Crosby Circle and running back to a depth of 150 feet on the north side, to a depth of 160.1 feet along the south side and being 24.6 feet across the rear.

The above described property is the same conveyed to the mortgagor herein by deed of Paramount Park, Inc., of even date and to be recorded herewith.
